This public hearing is the first of the two and will be held on Monday, August 23, 2010 and will continue, if necessary, on Tuesday August 24, 2010 at 9:00 a.m. at the Webb County Courthouse, Second Floor, 1000 Houston St., Laredo, TX, 78040. You have the right and are encouraged to attend the hearings and make comments if you wish.

- 2.** Open Public Hearing on Tax Increase (pursuant to Chapter 26, Tax Code) by Honorable Danny Valdez, Webb County Judge
- 3.** Public Hearing on Tax Increase. Last year, the Webb County property tax rate was 0.420055. That rate raised \$54,651,671 in revenues, a portion of which was used to fund operations such as law enforcement, judicial functions, county government, health and welfare, recreation and culture, community service, and other sources and uses. This year, Webb County is proposing a property tax rate of 0.420055. That rate will raise \$55,754,811, which is \$1,103,140 more in revenues than that raised by taxes imposed last year.

4. Announcement of the date, time and place of the Commissioners Court meeting at which a vote will be taken on the proposed tax rate.
