AGREED PRE-TRIAL COURT ORDER

CONDITIONS OF PRE-TRIAL DIVERSION PROGRAM

You have been placed on the Pre-Trial Diversion Program for a period of up to (24) twenty four months effective date _____.

It is agreed by the State of Texas, through the District Attorney's Office, that you comply with the following conditions of the C.S.C.D. Pre-Trial Diversion Program in that you shall during the period of supervision;

1. Pay the following, in one of several sums, through the Webb County Community Supervision Department, in whatever sum the Court shall determine during the term of your Pre-Trial Diversion, until all fees are paid in full. **A \$2.00 Administrative fee per transaction will apply.**
2. Pay a program fee of \$60.00 per month during the term of the Pre-Trial Diversion Program to the Community Supervision Office of Webb County, Texas.
3. Commit no offense against the Laws of this State or of any other State of the United States.
4. Report, in person, during the term of the Pre-Trial Diversion Program, to the Community Supervision Officer of Webb County, Texas, by appointment for the term of the program.
5. Report any change of address, change of job, or arrest to the Community Supervision Officer within 48 hours.
6. Avoid the use of alcoholic beverages and illegal drugs while participating in the Pre-Trial Diversion Program.
7. Avoid injurious or vicious habits and abstain from the illegal use of controlled substances, dangerous drugs, or use alcoholic beverages; submit to drug testing as directed by the Court or Supervision Officer as often as deemed necessary; pay a urinalysis fee of \$20.00 for each test to the Webb County Community Supervision and Corrections Department. ***Submit as directed to an alcohol/drug screening at your own expense; and follow through with the screening results.***
8. **Special Conditions:** Defendant is ordered to participate at the 406th District Court Drug Court Program and shall cooperate fully with all treatment requirements and obey all rules and regulations.

You are advised that under the Laws of this State, if you fail to comply with the Conditions of the Pre-Trial Diversion Program, the District Attorney's Office may at any time continue with the prosecution in this case and request a setting for trial without prejudice.

Should you successfully complete the terms of supervision, the State of Texas shall dismiss any complaint or information related to this case with prejudice, to hereby barring the State of Texas from any prosecution in this case.

I have read and/or had explained to me the conditions and fully understand the above waived and agreement and acknowledge receipt of a copy of this document.
