The County of Webb County reserves the right to reject any or all bids or to waive any informality in the bidding.

Bids may be kept by Webb County Purchasing Department for a period not to exceed 45 days from the date of the bid opening for the purpose of reviewing the bids and investigating the bidder's qualifications prior to awarding the contract.

Bidders are expected to inspect the site of the work and to inform themselves regarding all local conditions.

All contractors and subcontractors which are debarred, suspended or otherwise excluded from or ineligible for participation on federal assistance programs may not undertake any activity in part or in full under this project.
