This addendum has been issued to inform all interested parties of the following modifications to ITB 2017-004 and changes to previous addendum #1.

**DEADLINE REMAINS UNCHANGED AS MODIFIED UNDER ADDENDUM #1.**

- ✓ The deadline to submit ITB 2017-004 has been extended from Thursday, December 07, 2017 at 10 a.m. to December 14, 2017 at 10 a.m.

**DOR RESTRICTIONS HAVE BEEN REMOVED.**

- ✓ ~~Webb County will not accept any Dealer on Record Vendors. All Vendors submitting a bid proposal must provide a written confirmation from the 5.11 manufacture that no dealer on record exists for that vendor.~~

**OTHER BRANDS/EQUALS WILL BE ACCEPTED BY WEBB COUNTY**

- ✓ If the bid is based on offering other than the referenced or specified items, the bid must show the name of the manufacturer, brand or trade name, catalog number, etc., of article offered. If other than the brand(s) specified is offered, illustrations and complete descriptions must be submitted with bid.
- ✓ Samples may be required.
- ✓ Bidders must certify that item(s) offered meet and/or exceed specifications.
- ✓ If bidding alternate (or equal) brands, samples must be furnished free of expense to County at date specified by the County Purchasing Agent. If not destroyed in examination, they will be returned to bidder, if requested, at bidder's expense. Each sample must be marked with bidder's name and address when requested. DO NOT SUBMIT SAMPLES WITH BID SUBMISSION.

**CONTRACT QUANTITIES**

- ✓ The quantities specified in this Invitation for Bid are estimated only, and are given for the information of bidders and for the purpose of bid evaluation. They may not indicate the actual quantity, which will be ordered, since such volume will depend upon requirements, which develop during the contract period. Quantities shown shall not be construed to represent any amount, which the County shall be obligated to purchase under the contract, or relieve the bidder of his obligation to fill all orders placed by the County.
- ✓ NO BID WILL BE CONSIDERED WHICH STIPULATES THAT WEBB COUNTY SHALL GUARANTEE TO ORDER A SPECIFIC QUANTITY OF ANY ITEM.

**REVISED BID SHEET**

- ✓ ALL bidders must use the revised bid sheet attached with addendum #2.
- ✓ Bid unit price on quantity specified, extend and show total. In case of errors in extension, unit prices shall govern.
- ✓ Bid price must be firm for County acceptance for a minimum of ninety (90) days from bid opening date.
