- 2. Open Public Hearing on Tax Increase (pursuant to Chapter 26, Tax Code) by Honorable Danny Valdez, Webb County Judge.**
- 3. Public Hearing on Tax Increase.** Last year, the Webb County property tax rate was 0.420055. That rate raised \$57,629,160 in revenues, a portion of which was used to fund maintenance and operations such as for road and bridge, law enforcement, judicial functions, county government, health and welfare, recreation and culture, community service, and other sources and uses. This year, Webb County is proposing a property tax rate of 0.420055. That rate will raise \$62,182,031 which is \$4,552,871 more in revenues than that raised by taxes imposed last year.

4. Announcement of the date, time and place of the 2<sup>nd</sup> Public Hearing to consider the tax increase. The 2<sup>nd</sup> Public Hearing will be held on September 5, 2012, at 9:00 a.m., at the Webb County Courthouse, Second Floor, Commissioners Court, 1000 Houston St., Laredo, TX 78040.
