1. Roll Call by Honorable Margie Ramirez-Ibarra, Webb County Clerk
2. Open Public Hearing on Healthcare Funding District Commission by Honorable Danny Valdez, Webb County Judge.
3. This is a Public Hearing in accordance with Section 288.151, Chapter 288, Health and Safety Code to establish the mandatory payment rate the Webb County Health Care Funding District Commission intends to require from local hospitals (institutional health care providers) during Fiscal Year 2013-2014 and deliberation regarding how the revenue derived from those payments is to be spent; and any matters incident thereto. Notice of the Public Hearing was published in a newspaper of general circulation (Laredo Morning Times) on December 1, 2013.
4. Close Public Hearing on Healthcare Funding District Commission by Honorable Danny Valdez, Webb County Judge.

5. Discussion and possible action to adopt and approve an Order establishing the mandatory payment rate and amount required from local institutional health care providers (hospitals) in order to generate revenue to provide the nonfederal share of the Medicaid supplemental payment program in accordance with Section 288.201, Chapter 288, Health and Safety Code, and any other matters incident thereto. The mandatory payment may not exceed Six percent (6%) of the aggregate net patient revenue of all paying hospitals in the district.
6. Discussion and possible action to authorize an Inter-Governmental Transfer (IGT) to the State of Texas in connection with the Texas Healthcare Transformation and Quality Improvement Program/1115 Waiver via the Local Provider Participation Fund; and any other matters incident thereto. The funds for this transfer will come from the tax revenue collected and held in the Local Provider Participation Fund (Accounts #003-4109-3501, #003-4110-3501 and #003-4111-3501).
