


NOTICE OF MEETING

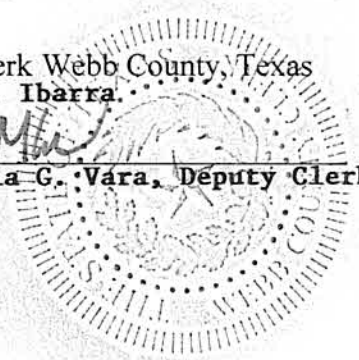
