1. **Call meeting to order.**

3. **Approval of January 2022 Board Meeting minutes.**

4. **Report on Pending Writs of Execution.**

Albrecht Riepen Board Counsel informed the Board that No Writs of Execution pending at this time.

5. **Report on Outstanding Agreed Judgments/ Default Judgments as of January 28, 2022.**
