

PERSONS AUTHORIZED TO CONDUCT CEREMONY

SEC. 183, Family Code. The following persons are authorized to conduct marriage ceremonies:

- 1. Licensed or ordained ministers and priests;**
- 2. Jewish Rabbis**
- 3. Person who are officers of religious organizations and who are duly authorized by the organization to conduct marriage ceremonies; and**
- 4. Justices of the Supreme Court, Judges of the Court of Criminal appeals, Justices of the Court of Appeals, Judges of the District, County and Probate Courts, Judges of the County Courts at Law, Courts of Domestic Relations and Juvenile Courts, retired Justices and Judges of such Courts, Justices of the Peace, retired Justices of the Peace, and Judges and Magistrates of the Federal Courts of this state.**
- 5. A Judge of a Municipal Court.**

The Marriage License expires at the end of the 90-day period immediately following the date the license is issued; if the ceremony has not been conducted within that period.

The marriage ceremony may not take place during the 72-hour waiting period immediately following the issuance of the license unless an applicant is a member of the Armed Forces of the United States and is on Active Duty or an applicant obtains a written waiver from a judge.
