

# Webb County Attorney Fee Schedule

Effective October 1, 2023

## ➤ MISDEMEANORS:

### Pleas or Dismissals

Flat fee \$500 authorized per case

Jail Visit – Flat Fee of \$100 (if a jail visit was made)

### Trial (Jury or Bench)

Full day (min 6 hours) – Flat fee of \$600

Half day – Flat fee of \$375

Hourly fee (WITH PRIOR WRITTEN COURT APPROVAL)

\$60 / hour with 10 hour cap
