# RFQ 2014-005 Webb County Design Build for the Wind Farm Industry Training Center Project in Bruni, Tx

## **Introduction**

Webb County and Webb Consolidated Independent School District are soliciting qualifications, for commercial Modular Manufacturing Companies with full design, manufacturing and installation capabilities of permanent brick & mortar buildings and additions for slab-on-grade site built construction, to develop a multiple phase project. This project will be a training center to be located on the Webb Consolidated Independent School District campus in Bruni Texas. The training center will focus on training individuals for programs dealing with the Whitetail Energy wind farm industry and FFA events. The first phase of the training center will be funded with \$300,000.00, with the subsequent phases totaling \$1.5million.

## **Scope of Work**

The scope of work for the project is to include the design of an expandable training center in multiple phases. First phase to include:

1. A steel building 100' by 150' to school code
2. A concrete foundation
3. Two walk in doors size 30x70
4. Four 20'x10 frame openings
5. Two 7'x10' frame openings
6. One 8'10' frame opening
7. One 3x10'
8. 3 inches of insulation on the roof and all sides
9. Office; 2 classrooms; task room; A/C closet; custodial closet; phone closet; and 2 ADA rest rooms
10. An expandable paved and striped parking lot with entrance and exit

## **Qualifications and project information**

1. This will be a 2 step process. Interested firms will submit their qualifications and other criteria requirements for consideration.
2. Webb County will rank the responding firms; the top ranked firms will be asked to submit their proposal.
3. Firms must be able to bond project up to 1 million dollars.

## **Criteria for ranking of firms**

1. Experience with design, manufacturing and installation of permanent brick & mortar buildings for slab-on-grade site built construction (40 Points)
2. References (10 Points)
3. Competition time after Notice to Proceed (10 Points)
4. Financial Capacity to perform (20 Points)
5. Performance on previous Webb County projects (20 Points)

### **Second Phase**

1. The second phase will ask the top ranked firms to submit proposals of the work they will do.
2. Firms will make presentations to a County committee.
3. Committee will make a recommendation for the award of the project to the Commissioners Court

## **Criteria for evaluation of proposals**

1. Responders selected for second phase will be evaluated by the Webb County Commissioner's Court.
2. They will be asked to prepare a proposal that will indicate to the court how they propose to phase in the project.
3. Proposal should include a general understanding of the work to be performed during each phase and the funding necessary for each phase.

**PART A.**
